AUCTION TERMS AND CONDITIONS

1. Persons under the age of 18 years are not eligible to bid.
2. ALL PROPERTY IS OFFERED AND SOLD "AS IS, WHERE IS". THE COMMONWEALTH MAKES NO EXPRESS OR IMPLIED WARRANTIES BEYOND THE FACE HEREOF, INCLUDING, BUT NOT LIMITED TO, FOR "MECHANTABILITY" OR "FITNESS FOR PARTICULAR PURPOSE".
3. All bidders are strongly urged to inspect items before bidding.
4. Bidders must register before bidding upon any item being auctioned. Bidder numbers may be obtained from 8:30 A.M. on the day of the sale until the last item has been sold. Bidders must provide two means of identification at the time of registration, a valid driver's license and a major credit card. Bidders are responsible for all bids on their number.
5. When registering to participate in an auction, bidder must inform office personnel the exact name he or she wishes to appear on the title. Under no circumstances may there be any names change made once the item has been sold.
6. The Commonwealth reserves the right to reject any and all bids and to withdraw any item before time of sale.
7. THE COMMONWEALTH SHALL NOT BE LIABLE FOR ANY INCIDENTAL OR CONSEQUENTIAL DAMAGES.
8. Full payment must be made immediately following the sale by credit card, cash, bank check or money order payable to Auctions International. Personal/business checks are no longer accepted.
9. No vehicle is to be started, moved, or worked on until completion of the auction.
10. The Commonwealth is not responsible for damage to auctioned items. Title passes to the buyer upon payment to the Commonwealth. It is advised that purchased items be removed immediately.
11. All items must be removed within five business days of the sale otherwise a storage fee of \$10.00, per day shall be assessed. Day and time of removal of auctioned items will be announced by the auctioneer just prior to the auction. No removal is allowed on weekends or holidays. ***Any vehicle not removed from the auction site within 30 days from date of sale will be considered abandoned property. If the vehicle is determined to be abandoned property the Commonwealth will take ownership of the vehicle and the bidder will not be reimbursed.***
12. **Police vehicles which have distinctive markings must be repainted with a solid color within thirty (30) days of sale.**
13. BID RIGGING IS A FELONY! Agreements among buyers at auctions not to bid against each other for the purpose of purchasing goods at low and non-competitive prices can be a criminal violation of the Federal Antitrust Laws, punishable by heavy fines and imprisonment. The Sherman Act prohibits bid rigging agreements among competitors if they affect or restrain interstate commerce. Upon conviction, individuals are subject to a maximum fine of \$100,000.00, and/or Three year imprisonment. Corporations are subject to a maximum fine of one million dollars.
14. SALE IS SUBJECT TO ADITIONS, DELETIONS, ERRORS, AND OMISSIONS. BIDDERS ARE RESPONSIBLE FOR LOADING THEIR PURCHASES.
15. **Please Note: Code "D" represents vehicle was driven onto the auction site.
Code "T" represents vehicle was towed onto the auction site.**
16. **"Parts Only" titles:** When a vehicle is issued a parts only title, the vehicle can not be rebuilt or registered for operation. The vehicle can only be used for parts, junking or scrapping.
17. **Bidders may be required to pay sales tax based on book value of the vehicle(s) they are purchasing at this sale.**

PAYMENT TERMS

- Seven percent (7%) buyer premium will be charged to the purchaser for each item sold with a \$1.00 minimum action receipt requirement.
- If the purchaser pays Auctions International Inc. by credit card, Auctions International, Inc. will charge purchaser a 3% credit card surcharge; such credit card surcharge will be in addition to the 7% buyer premium charged to the purchaser.
- **New for 2016-** Auctions International, Inc will be accepting personal and business checks. ALL buyers who pay with a personal or business check must provide a bank letter guaranteeing account funds, naming your checking account specifically. Furthermore, a copy of your current driver's license will be taken and attached to your invoice. (Any purchaser that pays with a bounced check will pay a \$500 Bounced Check fee and will be banned from all future auctions conducted on behalf of the OSD.
