After 10 days a \$25.00 daily storage fee may be assessed by the City of Poughkeepsie Police (CPPD). Pickup Hours are 8:00 to 2:00, Monday to Friday ONLY. Bring a legible copy of the paid invoice & a copy of your operator's license.

If someone other than the person listed on the paid invoice, is picking up the vehicle, a notarized letter authorizing such is required. Please be prepared to tow the vehicle out of the impound yard.

Once your invoice has been paid, please log into your Auctions International account and retrieve the Paid Invoice from your Invoices tab. You can then print it directly from there. Payment DUE within FIVE (5) business days, ANY MERCHANDISE LEFT ON PREMISES AFTER TEN (10) BUSINESS DAYS WILL REVERT BACK TO THE POSSESSION OF THE SELLER, WITH NO REFUND ISSUED.
